

PUPPY CONTRACT

HAZY DAISY DOODLES AGREES:

1. Your new puppy is guaranteed for a two year period for the disease of hip dysplasia. (With the stipulation that the puppy is kept at a suitable weight and the pup does not receive excess exercise before he/she is one year of age.) If the puppy develops such a severe case of dysplasia that it cannot function as a pet and must be euthanized, Hazy Daisy Doodles will replace your puppy with a puppy of equal or greater value, as soon as a suitable replacement becomes available. The buyer must return the ill puppy, and original registration papers, unless other arrangements are made by the breeder. The assessment of the severity of the disease must come from a vet approved by Hazy Daisy Doodles.
2. Your new puppy is guaranteed for a period of two years for problems of the congenital type requiring euthanasia.
3. If this pup dies in the seven days following the date of possession, a report of the veterinarian or an official autopsy will be necessary to determine the cause of death. If the death of the animal was caused by negligence or could have been avoided, the pup will not be replaced and there will be no refund applied. If the cause of death was the fault of Hazy Daisy Doodles they will replace the pup with a pup of equal or greater value as soon as a suitable replacement becomes available.
4. We do our best to keep all our puppies' parasite free, however sometimes they occur. It is the responsibility of the new owners to treat and prevent them.
5. This pup was seen by our veterinarian before being sold and was in good health. However, we strongly advise you to take your new pup to your own veterinarian with in the first three days of going home. If the said purchaser fails to take the below mentioned pup to a veterinarian within 72 hours this contract is null and void.
6. This guarantee is not transferable; it applies only to the original purchaser.
7. There are no refunds for the pup in the case of allergies to this pup, change of coat type or color, and/or any other reason not stated in this contract.
8. Hazy Daisy Doodles take no responsibility for any veterinarian costs whatsoever after the puppy leaves the premises of Hazy Daisy Doodles.

THE NEW OWNER/PURCHASER AGREES:

1. To ensure the pup does not have excessive exercise before one year of age.
2. To ensure the puppy must also maintain a suitable weight.

3. That the puppy will always be kept safe.
4. That the puppy will never be allowed to roam at large.
5. That the puppy will never be put in a shelter.
6. That the puppy will always have proper veterinary care.
7. That the puppy will always be loved and looked after.

I agree to have this pup spayed/neutered by one year of age. This dog is sold on a non-breeding contract and I agree not to breed it.

If for any reason the terms of this contract cannot be met or carried out by the new owner/purchaser, the puppy/dog is to be returned to Hazy Daisy Doodles and they will ensure a proper re-homing of the animal.
