TERMS AND CONDITIONS:

1. By signing this contract both parties agree that Hazy Daisy Doodles is releasing all claim to the retired dog and the Owner is assuming all the responsibility and liability of ownership.
2. The Owner releases Hazy Daisy Doodles from any and all liability related to the dog including that which is concerned with the dog's behaviour, health, and day-to-day care.
3. Hazy Daisy Doodles agrees that they will cover all expenses related to having the dog altered by a qualified veterinarian.
4. Hazy Daisy Doodles will not be held responsible for any further medical costs related to the dog or it's care.
5. Both parties agree that all further decisions related to the dog including medical and care decisions now rest with The Owner and Hazy Daisy Doodles no longer holds any rights or responsibilities in this regard.
6. The Owner agrees that they will not hold Hazy Daisy Doodles responsible for any expenses, including but not limited to, veterinary bills, food, medication, and necessities.

7. The Owner agrees to fill and submit a Microchip form, located on the website at **[www.hazydaisydoodles.com/ contact-page/microchip-form/](http://www.hazydaisydoodles.com/contact-page/microchip-form/)** within 14 days of the signing of this contract. (**Please note:** Under the "Ribbon Colour" please input "Retired Dog" and choose any available mother under "Puppy's Mother")
8. Once the microchip form has been submitted, Hazy Daisy Doodles agrees to have the information on the retired dog's microchip changed to The Owner's submitted information.
9. If the circumstances of the owner should change and they, for any reason, need to rehome the retired dog, they agree to first contact Hazy Daisy Doodles to give them first opportunity.
10. The Owner agrees that the dog will not, at any time, be released to a shelter.

Hazy Daisy Doodles is releasing all claim to this dog in good faith, under the condition that the Owner will continue to provide the proper veterinary, grooming, and day-to-day care required to keep the dog healthy and happy. If the Owner should find themselves unable to maintain this standard of care they agree to return the animal to Hazy Daisy Doodles.

Both parties agree that they have read and understood this contract in it's entirety and agree to abide by the terms and conditions contained within. By signing this contract, ownership of the retired breeding dog now passes to The Owner and Hazy Daisy Doodles releases it's claims on the animal.
